Movement /expansion joints in calcium silicate masonry walls should be constructed as "elastic" joints, accommodating both expansion and contraction of the veneer materials. Typically, movement joints should be placed: at changes in wall direction, at changes in building height, at wall openings, at major changes in wall thickness, at periodic lengths of continuous wall up to a maximum of 25 feet on center, at abutments to existing structures, and below shelf angles.
